Historical Background

From Bunker Hill Community College's (BHCC) inception, BHCC has conducted accreditation reports and been visited by the New England Association for Schools and Colleges (NEASC) for accreditation visits every ten years from 1980 onwards. From 2018 onwards, as a result of the U.S. Department of Education's requirement for independent accreditation organizations, NEASC's Commission in Higher Education was restructured into an independent organization called New England Commission of Higher Education (NECHE) which currently conducts BHCC's accreditation.

Scope and Contents

This collection documents the activities of the NEASC Steering Committee in preparing and creating materials for Bunker Hill Community College's (BHCC) accreditation visit from the New England Association for Schools and Colleges (NEASC). Composed of eleven standards for accreditation, BHCC's NEASC steering committee subdivided into eleven task forces to compose and collect materials for their assigned standards. At the time of the 2000 NEASC accreditation visit, the standards in respective numerical order were: Mission and Purposes; Planning and Evaluation; Organization and Governance; Programs and Instruction; Faculty; Student Services; Library and Information Resources; Physical Resources; Financial Resources; Public Disclosure; and Integrity.

Additional items created for the 2000 accreditation include Non-Unit Professionals (NUP) task forces meeting minutes. Reference materials such as prior BHCC administrative Self-studies, individual department and degree self-studies, prior reports to NEASC, and binders composed of materials used by select task forces are also included. Materials from the 2010 and 2020 NEASC/NECHE accreditation cycles are also found in the collection. The collection consists of task force meeting minutes, binders, memos, letters, reports, presentations, surveys, raw data, booklets, and books. The collection is primarily text-based.

Arrangement

This collection is arranged into three series and fifteen sub-series.

Collection Inventory

This series consists of meeting minutes, memos, letters, reports, binders, and booklets created and consulted for the creation of BHCC's accreditation report and on-site visit from NEASC in the year 2000. The materials are dated between 1974 to 2000, with the bulk of the materials created from 1993 to 2000. The series is divided into fifteen sub-series reflective of the NEASC standards, previous self-study reports, and miscellaneous documents created for and referenced for the accreditation report. The arrangement also reflects the initial organizational structure prior to creation of this finding aid.
