Quick Facts

- ◆ The BHCCPD is made up of academy trained and sworn police officers with arrest powers, just like any other city/town police department.
- ◆ BHCCPD conducts annual mandatory in-service training and firearms qualifications as well as additional training throughout the year. Such as: Fair and Impartial Policing, Mental Health First Aid, Transgender Awareness Training and ICAT (Integrating Communications Assessment and Tactics).
- ◆ Officers specialize in areas such as Firearms Instructor, Armorer, Defensive Tactics Instructor, Sexual Assault Investigator, R.A.D. Instructor, Emergency preparedness and active shooter awareness Instructor, Bicycle Unit, Criminal Investigations Unit etc.
- ◆ In addition to the Police Officers, the Department also has two dispatchers, a staff associate and a comfort dog, Wiley.

Emergency Procedures

Emergency Procedures



Active Shooter

Escape if safe to do so.

If you know location of assailant, consider escaping if a safe route is available.

If unsafe to escape:

- Lock and barricade doors.
- Turn off lights and close blinds.
- Keep out of sight and take adequate cover behind concrete walls, thick desks or file cabinets.
- Silence cell phones, radios and televisions.
- Do not leave your classroom/work space until notified via BHCC alert or a building coordinator or BHCC police officer/security.

If an armed intruder comes into your office or classroom:

- If possible, identify an escape route behind you.
- If flight or escape is impossible and there are no other options, make a personal choice to negotiate with or overpower the armed intruder.



Hurricane

- Go to rooms and corridors in the innermost part of a building.
- Stay indoors during the hurricane and away from windows and glass doors.
- Close all doors, including those in main corridors, making sure they latch.
- Avoid being under heavy objects such as lights, wall hangings and other items which may fall.
- Do not use elevators.
- Remain inside until the hurricane has passed or you are cleared to leave.
- Help direct people with special needs or disabilities to a safe place.
- If you're caught outdoors, lie flat in nearest depression (a ditch or ravine) and cover your head.



Hazardous Materials/Chemical Spills

- Alert people to evacuate the immediate spill area.
- Alert the BHCC police department.
- Avoid breathing vapors from spilled chemicals or substances.
- If personally contaminated, seek eye wash and/or emergency shower.
- If clothing or footwear is contaminated, remove if possible before leaving the area of the spill.
- Do not attempt to clean up the spill on your own. Leave it to the experts.
- Do not operate any electrical devices, phones (including mobile), appliances, light switches or equipment with open flames, within spill area.
- Re-enter area only when directed by authorities.



Fire

- Walk to nearest exit; do not use elevators.
- Activate the nearest fire alarm or call 911.
- If caught in smoke, crawl to nearest exit.
- Hold your breath as much as possible; breathe through your nose and use a filter such as a shirt, towel or scarf.
- Assist persons with disabilities/special needs and direct emergency responders to location of disabled or trapped persons.
- Meet at designated assembly areas.
- Move away from building entrances.



Severe Winter Storm

- The public will be notified via radio, TV, BHCC Alert, Twitter, Facebook and the College website if the College plans to close or close early.
- Stay safe, warm, dry and calm.
- Do not drive unnecessarily.
- Dress warmly enough to prevent frostbite and hypothermia.
- Do not go outside unless absolutely necessary.
- When shoveling snow, do not overtax your physical abilities; take frequent breaks.



Suspicious Activities and Packages

- Always report unusual or suspicious activity to the BHCC police/security department. Call ext. 2222 or 617-228-2222.
- Alert others in the area.
- If you see a suspicious package, do not open or shake it.
- Do not pick up or carry suspicious packages or show them to others.
- Do not sniff, touch or taste suspicious items.
- Leave the area and prevent others from entering.



Power Outage

- Remain calm and follow directions of BHCC police.
- Secure all experiments, unplug all electrical equipment, turn off light switches, and shut off lab equipment.
- Do not use candles or other types of flame for lighting.
- Fully close fume hoods.
- If trapped in an elevator, do not pry open elevator doors. Use the emergency phone to contact campus police.

Be prepared.
Remain calm.
In emergencies,

Medical Emergency

- Activate Emergency Medical Services by calling ext. 2222, 617-228-2222 or 911.
- If trained, administer First Aid or CPR or utilize an automated external defibrillator (AED) as needed.
- If not trained, remain calm and direct first responders to the incident.
- Reassure the victim that help is on the way.

Safeguarding your Personal Property

Do Not Leave Your Belongings Unattended

- ◆ Bags, wallets, textbooks, phones, tablets, laptops, etc.
- ◆ Record serial numbers and detailed model information of high-end items.
- ◆ Keep all valuable portable electronics close to you at all times or store them in a secure location.

Always Remember to Lock Your Vehicle

- ◆ Remove device mounts and their marks from the windshield.
- ◆ Remove electronic cables from view.

Do Not Share Personal or Banking Information with Strangers

- ◆ Identifying information such as your Date of Birth, Address, Social Security Number, any account numbers, etc.
- ◆ Be wary of IRS, SSN and other phone scams that ask for this.

Restricted Access Areas

- ◆ Do not prop open emergency exit doors.
- ◆ Do not tamper with or obstruct surveillance and alarm equipment.
- ◆ Do not prop open doors such as Honors Room, Labs, and anything that has restricted use.

Taking a Break?

If you are leaving your study area, take all your belongings with you.
Avoid being a victim to theft – DO NOT leave your belongings behind!

Disciplinary Offences

Disciplinary Offences

- ◇ **STUDENTS ARE SUBJECT TO DISCIPLINARY ACTION AND/OR POLICE ACTION FOR VIOLATION OF THE STUDENT CODE OF CONDUCT AND/OR ALL STATE AND FEDERAL LAWS.**

This includes but is not limited to:

- Failure to comply with the directions/orders of a police officer or college official, including failure to identify yourself when requested to do so and/or providing false information.
- Any type of harassment, threats, violent acts, domestic violence.
- Any breach of peace such as being disruptive in class or disturbing the normal functions of the College
- Any type of larceny/theft or attempt to commit such crime.
- Unauthorized use of a fire alarm or other fire equipment .
- Possession of any dangerous weapons on campus.
- Creating or false reporting of bombs or other dangerous devices.
- Use, possession, or distribution of any drugs or controlled substance.
- Alcohol, marijuana, heroin, narcotics, etc.
- Smoking any tobacco products/e-cigarettes/vaporizers/inhalers inside the campus buildings or near any entrances to the buildings.
- Any destruction of college or personal property.
- Trespassing on any college property after notice.
- Violation of any other policies or laws not mentioned here, whether on campus or off campus.

We work closely with numerous other police agencies.

Marijuana/Alcohol

- ◇ **USE OR POSSESSION OF MARIJUANA/ALCOHOL IS STRICTLY PROHIBITED ON ANY BUNKER HILL COMMUNITY COLLEGE PROPERTY.**

On December 15, 2016, Massachusetts passed a law making marijuana legal under certain guidelines:

- BHCC is on state property, therefore, we follow and enforce federal drug laws.
- Drug use/possession on BHCC property is also against the BHCC Behavior Policies.

Title IX

What is Title IX?

Title IX of the Education Amendments of 1972 is a federal civil rights law that prohibits discrimination on the basis of sex in education programs that receive federal financial assistance. Gender-based discrimination, sexual harassment and acts of sexual violence such as rape, sexual assault, sexual exploitation, dating violence, domestic violence and stalking are all forms of sex discrimination prohibited by Title IX and BHCC policy.

What is a Title IX Coordinator?

The Title IX Coordinator is responsible for administering College policies and BHCC's discrimination complaint procedure concerning all Title IX Offenses. Definitions

Gender-Based Discrimination

- Unwelcome conduct of a nonsexual nature based on a student's actual or perceived sex, including conduct based on gender identity, gender expression, and nonconformity with gender stereotypes

Sexual Harassment

- Unwelcome sexual advances, requests for sexual favors, and verbal or physical conduct of a sexual nature

Sexual Violence

- Physical sexual acts perpetrated against a person's will or where a person is incapable of giving consent such as rape, sexual assault, sexual exploitation
- Includes dating or domestic violence and stalking

Consent

- Consent must be informed, voluntary, and mutual, and can be withdrawn at any time. There is no consent when there is force, expressed or implied, or when coercion, intimidation, threats, or duress is used. Silence or absence of resistance does not imply consent. If a person is mentally or physically incapacitated or impaired so that such person cannot understand the fact, nature, or extent of the sexual situation, there is no consent. This includes impairment or incapacitation due to alcohol or other drug consumption, or being asleep or unconscious. Further, there is no consent if a person is younger than sixteen years old (the age of consent in Massachusetts).

Student Parking - Rules & Regulations

BHCC offers limited parking for students on the Charlestown and Chelsea Campuses in designated areas from 6 a.m.-11 p.m. A valid parking permit is required for all vehicles parked on campus. Parking is available first come, first served. A parking permit does not guarantee a parking spot.

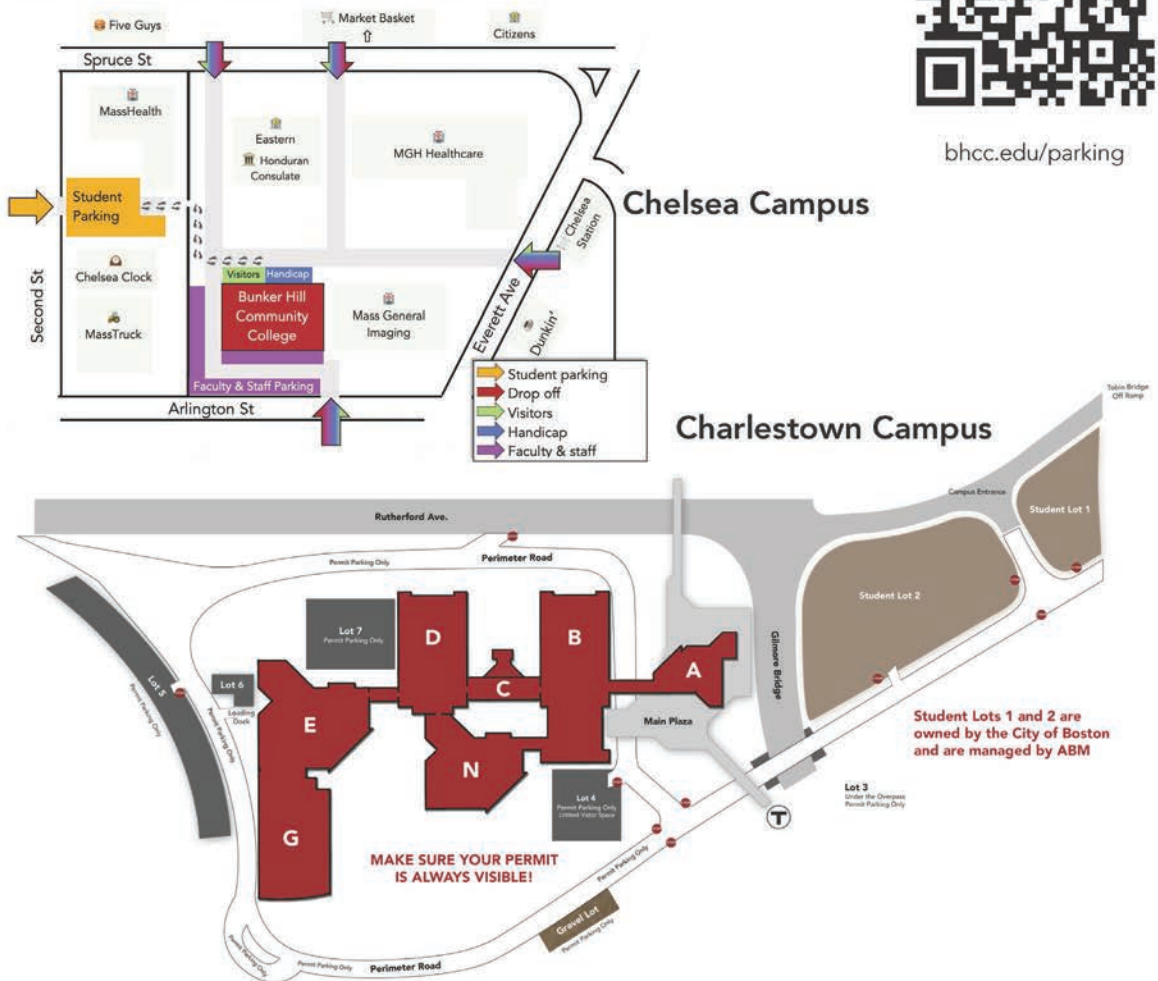
Students in need of temporary handicap permit contact Disability Support Services.

Student Parking Passes are now purchased online, managed by ABM Parking. The student parking lots (1 and 2) are owned by the City of Boston.

Students must purchase and display a parking pass or they are subject to a tire lock (or "boot") with a \$50/day fine.

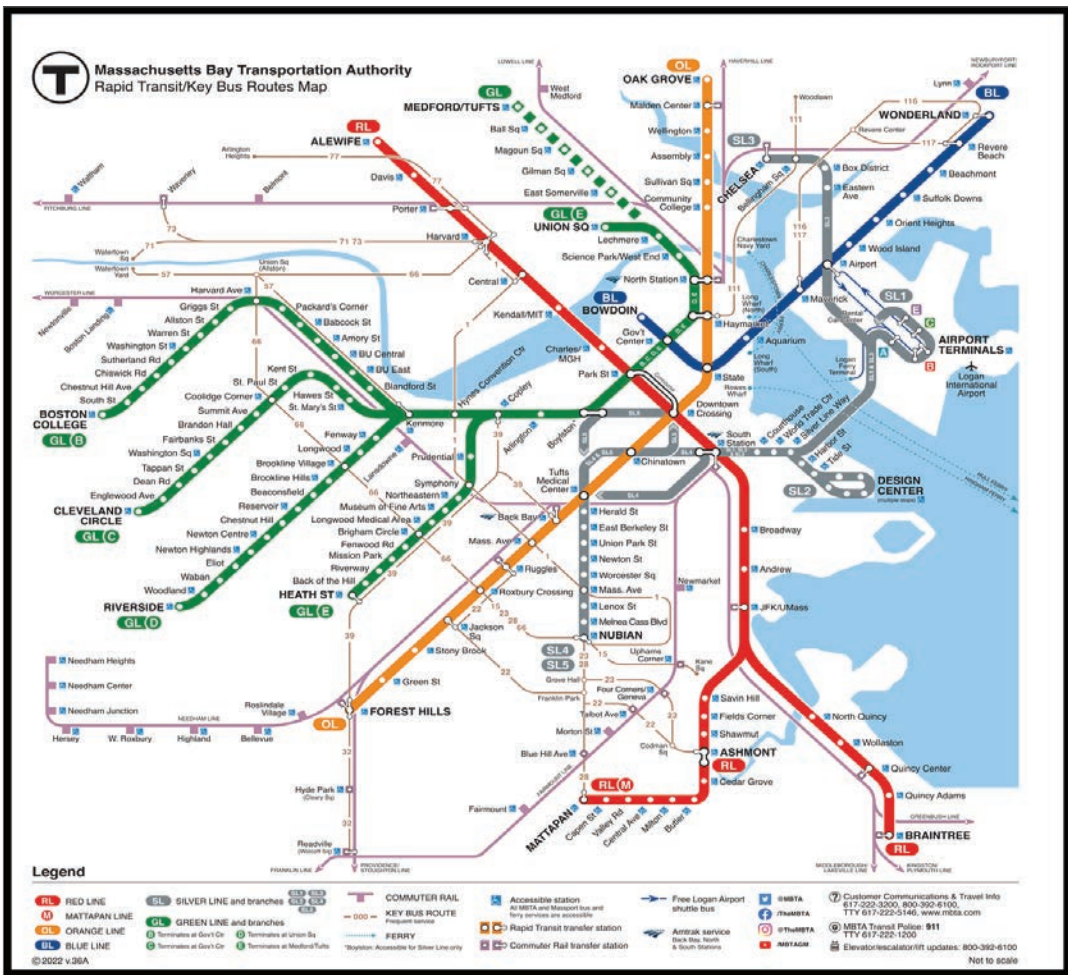

Protect your every day.

RECOGNIZE THE SIGNS OF TERRORISM-RELATED SUSPICIOUS ACTIVITY



EXPRESSED OR IMPLIED THREAT

Threatening to commit a crime that could harm or kill people or damage a facility, infrastructure, or secured site



SURVEILLANCE

A prolonged interest in or taking pictures/videos of personnel, facilities, security features, or infrastructure in an unusual or covert manner



THEFT/LOSS/DIVERSION

Stealing or diverting items—such as equipment, uniforms, or badges—that belong to a facility or secured site



TESTING OR PROBING OF SECURITY

Investigating or testing a facility's security or IT systems to assess the strength or weakness of the target



AVIATION ACTIVITY

Operating or interfering with the operation of an aircraft that poses a threat of harm to people and property



BREACH/ATTEMPTED INTRUSION

Unauthorized people trying to enter a restricted area or impersonating authorized personnel



ACQUISITION OF EXPERTISE

Gaining skills or knowledge on a specific topic, such as facility security, military tactics, or flying an aircraft



ELICITING INFORMATION

Questioning personnel beyond mere curiosity about an event, facility, or operations



MISREPRESENTATION

Presenting false information or misusing documents to conceal possible illegal activity



CYBERATTACK

Disrupting or compromising an organization's information technology systems



RECRUITING/FINANCING

Funding suspicious or criminal activity or recruiting people to participate in criminal or terrorist activity



SABOTAGE/TAMPERING/VANDALISM

Damaging or destroying part of a facility, infrastructure, or secured site



MATERIALS ACQUISITION/STORAGE

Acquisition and/or storage of unusual materials such as cell phones, radio controllers, or toxic materials



WEAPONS COLLECTION/STORAGE

Collection or discovery of unusual amounts of weapons including explosives, chemicals, or other destructive materials



SECTOR-SPECIFIC INCIDENT

Actions which raise concern to specific sectors, (e.g., power plant) with regard to their personnel, facilities, systems, or functions
